HAZARDOUS SUBSTANCES IN THE URBAN ENVIRONMENT

Releases of environmentally hazardous substances are increasingly linked to consumption-related diffuse sources rather than production-related point-sources. Among the sources that are becoming more and more important are household chemicals, personal care products, construction materials, electric and electronic products and textiles. Substances related to these sources include plasticizers, brominated flame retardants, endocrine disrupting substances and several others.

The shift towards consumption-related releases means that population centres are becoming virtual hotspots for pollution. Dealing with diffuse sources raises new challenges since legislation and other available tools are traditionally directed towards point-sources Thus, there is a need to develop new methods to deal with these sources. Such methods include for example information, green procurement, cooperation with stakeholders and new approaches in supervision.

The seminar "Hazardous Substances in the Urban Environment" will focus on experiences on prioritizing substances and sources for the local work. It will also be an opportunity to discuss what kind of possibilities European cities have to act on the diffuse sources and the needs to develop new tools. Experiences from Stockholm and other parts of Europe will be presented during the seminar.
